
## Social Housing Regulator - Consumer Standards Consultation

In July 2023, the Social Housing (Regulation) Act 2023 became law. This Act updates the Social Housing Regulators responsibilities and powers, strengthening how they can regulate landlords. As part of this process the Social Housing Regulator is creating four consumer standards which landlords will be required to meet.

## Safety and Quality Standard

- Providing safe, good quality homes is the main purpose of a landlord. The Safety and Quality Standard would mean landlords have to provide their tenants with safe, good quality homes and effective services.

 Transparency, Influence and Accountability
 Standard - To improve tenant-landlord relationships, tenants need to be able to get relevant information from their landlords, and landlords need to listen to their tenants and act on their views.



## Social Housing Regulator - Consumer Standards Consultation

- Neighbourhood and Community Standard Part of a landlord's role is to work with others to help with the upkeep and safety of neighbourhoods and communities their homes are part of. The proposed Neighbourhood and Community Standard would say landlords need to work with other organisations to help make sure tenants can live in safe and well-maintained neighbourhoods.
- Tenancy Standard The new Tenancy Standard would require landlords to allocate and let homes fairly, and set expectations for how landlords manage and end tenancies.

The Social Housing Regulator wants to hear from tenants, landlords and any interested parties on their views of the proposed Consumer Standards. The closing date is 17th October 2023.


