Digi-Comm

As part of the Digi Comm Power Up, we have just finished delivery at Friar Park Millennium Centre, and we are working with the staff there to ensure there is a lasting legacy (including donation of Chrome Books). On the same project, we are approximately half way through delivery with the Great Bridge Community Forum based at Farley Park Lodge, with some great feedback received so far.

In addition to this, on Digi Comm Unity, we have now commenced a new round of training at Kenrick House; we have reached out to the residents of other nearby buildings to join the training both as participants and champions. This will be our final venue for the KYN funded project, and we will be hosting a small event in March to thank everyone involved for making the project the success it has been (more details to follow).

Social Housing Regulator Consumer Standards UPDATE



In SCIPS September newsletter, we encouraged all tenants to have their say by completing the consultation on the proposed Consumer Standards being undertaken by the housing regulator. This consultation closed on 17th October 2023.

A reminder of the 4 Consumer Standards and Code of Practice

- 1. The Safety and Quality Standard requires landlords to provide a safe and good quality home.
- 2. The Transparency, Influence and Accountability Standard requires landlords to be open and treat tenants with fairness and respect.
- 3. The Neighbourhood and Community Standard requires landlords to engage with other relevant parties.
- 4. The Tenancy Standard sets requirements for the fair allocation and letting of homes

The Code of Practice is designed to help landlords understand how they will meet the requirements.

The regulator will expect landlords to

- Carry out an annual satisfaction survey. The results of this survey will be submitted to the regulator
- Comply with the Tenant Satisfaction Measures which are key performance indicators to ensure the landlord is compliant
- To evidence how tenants' views have influenced service delivery

The social housing regulator will be undertaking a programme of inspections to independently check if landlords are compliant.

Current status

- The Regulator undertook a national consultation which closed in October 2023.
- They have yet to publish the final Consumer Standards and the Code of Practice. SCIPS Board submitted a response to the consultation.
- The Standards will come into force on 1st April 2024
- The council will need to involve tenants in deciding how they will comply with the standards
- We want as many tenants as possible to be aware of these and participate in developing and monitoring the standards
- We have had no further information on how Sandwell intend to approach the development of the Standards So watch this space!!


As you can see the community orchard is starting to take shape in Hateley Cross. The work has begun in earnest
